PRESIDENT'S REPORT

2008 has seen another year of consolidation for Ausglass with the successful completion of the Open House Conference in Canberra in January 2008 together with its associated workshops and exhibition and the awarding of Honorary Life Membership to Klaus Moje. Again I would like to thank the Open House Conference Organising Committee of Richard Whiteley, Kirstie Rea, Charles Higgins and Mel Douglas for bringing together an amazing conference.

Our main focus since the Canberra Conference has been the planning and preparation for the 2009 Conference in Hobart, 'Glass Roots'. As everyone is aware, planning a conference by a group of volunteers is an enormous task and I am deeply grateful to the Conference committee comprising Arthur Sale, James Dodson, Richard Clements and Merinda Young who have made an enormous contribution. I would also like to thank all the Tasmanian glass community for their work in bringing the conference together. I must also give my appreciation to the School of Art of the University of Tasmania who will host the conference and have been most supportive.

The Board is pleased to announce that planning is underway for a 2011 Conference in Sydney, NSW. A conference task force has commenced planning.

I would like to thank the Ausglass Board for their commitment and work for the organisation, each having taken up numerous roles and offering perspectives which balance the running of the organisation. Kirstie Rea resigned from the Board on November 17, 2007. Kirstie was part of the Canberra Conference Organising committee and both I and the Board extend our thanks to her for her contribution and effort and best wishes for her future. We also welcomed Andrew Lavery at the AGM in January. Andrew will Chair the Conference Committee for the 2011 Sydney Conference.

Simon James continues to do an amazing job as our newsletter Editor, and I would particularly like to thank him for editing the Newsletter every three months. This is an onerous task but an essential one for Ausglass in keeping the flow of information strong.

Congratulations to Annette Blair who was the winner of the second Ausglass Vicki Torr Online Gallery prize. The third Ausglass Vicki Torr Online Gallery prize is currently underway and the winner will be announced at the Conference in Hobart in January, 2008. The Online Gallery remains a strong source of information for visitors to the website and we now have 75 exhibitors. I encourage all members to take advantage of the opportunity to exhibit through the Ausglass Online Gallery.

Congratulations also to Lee Mathers who was the winner of the Vicki Torr Memorial Prize announced at the Canberra Conference together with all the winners of the prizes at the Open House Conference.

I would like to particularly thank Arthur Sale for his continuing work with the Website. Arthur's vigilance and guidance together with his computer expertise have enabled the website to grow and be maintained at a high standard.

I am also extremely grateful to Julien Stannus who maintains the Ausglass Online Gallery.

I would also like to thank and acknowledge the State Representatives and the State Representative Liaison Officer, all of whom endeavour to coordinate information and bring this to the Board and Members. I also thank them for their contributions to the Newsletter.

Sadly Pauline North has relinquished her role as State Representative Liaison Officer. Pauline has held this position for over six years and has been an enormous asset to us. She has been a great contributor not only as Liaison Officer but also in her efforts in organising the Flair exhibitions in WA which has brought recognition of glass to that State and contributed financially to the organisation. I wish Pauline well in her future endeavours and thank her again.

This year we welcomed Bethany Wheeler and Nadia Mercuri as State Representatives for Victoria, Marcus Dillon for NSW, Bronwyn Fife for Qld & NSW and Rosa Kang for ACT. We have also farewelled Brenda Page and Kristin McFarlane from Victoria, Michelle Donde from NSW and Nikki Main from the ACT.

I am also grateful to Anne Yule from Minter Ellison Lawyers, our Minute Secretary. This is a most important position and we are most appreciative that she continues to do this.

We once again find ourselves in a strong financial position with consolidation of the basic functions of the organisation and in a strong position for the future. We look forward to receiving ideas from our membership and people interested in contemporary glass in Australia.

This is my last report as President with my term finishing following the Annual General Meeting (AGM) in Hobart. I Have enjoyed my role enormously and am deeply grateful to have been working with such a fantastic team that has comprised the Board over the past three years. Thank You.

I look forward to seeing everyone in Hobart at the Conference and the AGM in January.

TREASURER'S REPORT

For the year ended 31 October 2008 Ausglass generated a surplus of \$115,108 before transfer of investment income to the Vicki Torr Reserve (VTR) of \$5,836. This continues the improvement achieved since 30 June 2004. The results for the current year can be compared to recent prior period results as follows:

Ausglass has continued to improve its financial position during the current financial year with a significant improvement over the previous year. The surplus generated in the current year can be attributed to:

- A small increase in membership income as a result of the interest generated by the conferences;
- A surplus generated by the Canberra conference as a result of;
 - A record 231 people attending as compared to a budgeted breakeven attendance of 160;
 - Donor, grant and sponsorship income of over \$44,000 as a contribution towards the cost of running the conference;
 - o Raising over \$44,000 from the Charity auction held at the end of the conference; and
 - The considerable volunteer effort of the Canberra Conference Committee and the glass community in general with generous support from the Canberra Glassworks and ANU ensuring that the conference was delivered for as low a cost as possible;
- Investment income earned during the year of \$20,000, an increase on the previous year of more than \$11,000;
- All these gains being partially offset by an increase of over \$5,000 in total administration expenditure to approximately \$17,000.

The aim now is to run a successful Glass Roots Conference in Hobart, to keep other costs under control and to further build Ausglass' financial resources so as to enable Ausglass to further improve members' services.

Cash reserves have, in the current year, increased to \$257,600 and, in addition, the Vicki Torr Fund balance now stands at \$91,800. Given that having financial strength is a key to determining what Ausglass can do for its members, it is important that Ausglass' financial base, as at 31 October 2008, be preserved and increased whenever possible. To this end the policy of the Board of Ausglass continues to be that the association should, at least, break even in non-conference years and that it should make a surplus in conference years. The challenge will be to ensure that this happens during the 2009 financial year.

That's it for this year. Ausglass has further strengthening of its financial position during the current year and the Board is determined, with the help of members, to maintain this position.

THINGS YOU SHOULD KNOW ABOUT AUSGLASS

Ausglass' goals and objectives:

Our vision is to be recognised as the foremost body for the promotion of contemporary glass in Australia. We seek to achieve this by fostering effective communication between our members and interested parties.

Our Organisation's structure:

Ausglass (The Australian Association of Glass Artists) Limited is a public company limited by guarantee, which operates pursuant to its Constitution and the Corporations Act 2001. Every member undertakes to contribute an amount to the company in the event that it is wound up and does not have sufficient funds to meet its debts and obligations. This guarantee is limited to \$10 for each member and applies in the event that the company is

wound up whilst he/she is a member or within one year of their membership ceasing. The company operates on a non-profit basis. This means that any profits, income or property of the company cannot be paid or distributed directly or indirectly to its members.

Deductible Gift Recipient (DGR)

In 2007 the Australian Taxation Office (ATO) issued notices to Ausglass endorsing it as a DGR and also confirming its status for Charity Tax Concessions (CTC). The DGR endorsement means that Ausglass has now been placed on the Australian Register of Cultural Organisations.

Both endorsements are significant in that the majority of philanthropic organisations, government bodies and educational institutions now insist on proof of DGR and CTC status before providing financial assistance or provide concessionary access to their facilities. DGR certification can benefit Ausglass because:

- It enables funding and assistance to be obtained from a wider range of funding bodies; and
- It enables tax deduction certificates to be issued, in specified circumstances, to people or organisations making donations to Ausglass.

DGR does not come without cost as there will be ongoing ATO reporting requirements and there are accounting requirements that require specific treatment of funds received for which Ausglass has issued a tax deduction certificate but, provided that Ausglass adheres to these rules, there is scope to obtain better funding for projects that comply with Ausglass' Objectives, as set out in its constitution, and which are in compliance with the Government's intentions in issuing DGR certificates.

Volunteers Run Ausglass:

The company has a Board of volunteer directors who are elected by voting members, although the directors may appoint or co-opt other directors to the Board to fill vacancies that may occur. Elected directors are appointed for a three-year term and for a maximum of two terms. Co-opted directors serve until the next election but may offer themselves up for re-election. The board meets at a face to face meeting, at least once a year, and monthly by teleconference during the rest of the year.

The Board of Directors is responsible for running Ausglass and appoints office bearers from its ranks.

Local contact with members is maintained through volunteer State and Territory Representatives who are appointed by voting members for a period of two years. State and Territory Representatives are charged with the responsibility of implementing state/territory initiatives including activities such as member's meetings, workshops, exhibitions, etc.

The organisation does not employ any staff. However, it may from time to time, contract out services.

THE VICKI TORR MEMORIAL FUND

The Vicki Torr Memorial Fund was first established in 1993 as a memorial to Australian glass artist, Vicki Torr (1949-1992). Its purpose is to reflect the philosophies of Vicki's life and work, and to this end its stated aim is to encourage excellence in Australian studio glass through the awarding of the Vicki Torr Memorial Prize. Past recipients of the prize have been: Kirstie Rae 1999, Scott Chaseling 2001, Simon Butler 2003, the 2005 joint recipients, Cobi Cockburn and Daniela Turrin and Lee Mathers 2008.

During 2006 The Ausglass Directors instituted a new prize, The Vicki Torr Online Gallery Prize for emerging glass artists who exhibit in the Ausglass Online Gallery. It is hoped that this prize will develop into a significant prize for emerging glass artists and will help the Ausglass Online Gallery become a significant space for promoting contemporary glass practitioners. The first two winners of The Vicki Torr Online Gallery Prize were Nicole Ayliffe 2006 and Annette Blair 2007.

HONORARY LIFE MEMBERSHIP

The Ausglass Honorary Life Membership Award was first instituted in 1999. It is awarded in recognition of an outstanding contribution to this organisation and/or, more generally, the field of contemporary studio glass. The recipient is selected by the Ausglass Board on the recommendation of its Honorary Life Membership Sub-Committee. The Committee makes its recommendations based on nominations received from members through a formal nomination process. The awarding of an Honorary Life Membership is announced at the next

conference. Previously, Honorary Life Memberships have been awarded to Maureen Cahill, Judith Le Lievre, Klaus Moje and Anne Dybka (deceased 2007).

THE AUSGLASS NEWSLETTER

Ausglass produces a quarterly electronic newsletter for its members and this is the major vehicle for the organisation to communicate with its members. Contributions to, and the editing of, the newsletter is provided totally by volunteers but support from members is still needed. THE AUSGLASS WEBSITE AND MEMBERS@ E-MAIL GROUP

The Ausglass Website is an important vehicle for Ausglass to communicate with its members and the general public and assists Ausglass in meeting its objectives. The Website currently incorporates:

- A brief history of Ausglass and a copy of its constitution;
- A copy of the Code of Conduct for Directors and Executives;
- Copies of recent newsletters and recent annual reports;
- The Ausglass Online Gallery;
- The members@ausglass.org.au communication system:
- Details of recent and upcoming conferences; and
- Membership information, membership update forms and membership application forms.

The Ausglass Online Gallery is open to all contemporary glass artists (other than affiliated members) who pay the appropriate annual subscription fee. Details of how to exhibit in the gallery are to be found at <u>www.ausglass.org.au</u>. Since the establishment of the Vicki Torr Online Gallery Prize the number of exhibitors in the gallery is exceeds 70 and continues to grow.

Under the guidance of Arthur Sale, the Website assists in providing information and services to members.

Ausglass has an e-mail group, <u>members@ausglass.org.au</u>, which enables all members who have provided their e-mail address to the membership secretary to communicate with other Ausglass members provided that they follow the instructions contained on the Ausglass Website.

STATE AND TERRITORY ACTIVITIES

The State and Territory representatives have the task of identifying and coordinating member activities on a state by state basis. As part of this mandate, State and Territory Representatives endeavour to ensure that at least four state meetings take place each year. All State members are invited to attend. These meetings provide a forum for discussion of organisation or industry specific issues, and are usually accompanied by presentations on current topics by a member or industry professional.

In order to ensure that issues discussed and raised by members at state level are effectively communicated to the national body, the board has accepted Anne Clifton's offer to act as the State/Territory Representative Liaison Officer. This allows an efficient channel of communication between the states/territories, and provides the Board with feedback and specific state input to national directives.

Apart from general meetings, State and Territory representatives are also encouraged to discuss other initiatives with the membership. Initiatives such as the Western Australian based Flair exhibition will continue, but such initiatives can only continue with the support of the membership.

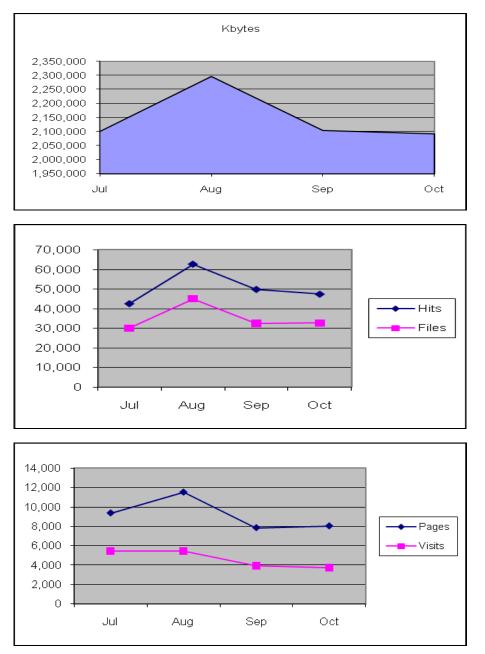
THE AUSGLASS CONFERENCE

The Ausglass Conference is usually held biennially. However, in 2007 a decision was made to celebrate the 30th anniversary of Ausglass by holding a conference in Tasmania, the state where the Australian glass movement first gained significant momentum just on 30 years ago. A Tasmanian Conference committee was established and the Ausglass conference 'Glass Roots' will be held in Hobart from January 16-18, 2009. To bring the organisation back into line with our previous two-yearly conference program, the next conference will be held in Sydney in January, 2011. A conference task force has commenced planning.

AUSGLASS WEBSITE TRAFFIC

Ausglass, with input and site development by Arthur Sale, continues to progressively upgrade our website. The graphs below provide a recent history of traffic on the Ausglass Website.



The peak in traffic in August is clearly a result of members and non members checking the website to find out details of the Glass Roots Conference in the period after the details were first published at the start of August. Overall website traffic has increased significantly over the volumes that were published in last year's report and this trend indicates that the Ausglass site has become a regular visiting site for people interested in glass and this should encourage more members to increase their Australian and international exposure by exhibiting in the Ausglass Online Gallery.

DIRECTORS' REPORT

The directors of Ausglass (The Australian Association of Glass Artists) Ltd submit herewith the annual financial report of the Company for the year ended 31 October 2008.

Directors have been in office since the start of the financial year to the date of this report unless otherwise stated.

Principal Activity

The principal activity of the Company during the financial year was to contribute to the advancement of contemporary glass in Australia. No significant change in the nature of these activities occurred during the year.

Review of Operations

A review of the operations of the Company during the year ended 31 October 2008 and the results of those operations found that Ausglass held its first conference since 2003. During the current year the Board concentrated on supporting the Canberra Conference Committee in planning, implementing and delivering the Open House Conference held in Canberra in January 2008. Since the completion of that conference the Board has turned its attention to supporting the Tasmanian Conference Committee in planning and implementing the 30th anniversary Glass Roots Conference to be held in Hobart in January 2009.

The surplus for the year after providing for income tax amounted to \$115,108 (2007 - \$21,138 surplus). This surplus is before the allocation of a net \$836 to the Vicki Torr Memorial Fund (2007 - \$4,194).

Change in State of Affairs

There were no significant changes in the state of affairs of the Company during the financial year.

Subsequent Events

There has not been any matter or circumstance occurring subsequent to the end of the financial year which has significantly affected or may significantly affect the operations of the Company, the results of those operations, or the state of affairs of the Company in future financial years.

Future Developments

Disclosure of information regarding likely developments in the operations of the Company in future financial years and the expected results of those operations is likely to result in unreasonable prejudice to the Company. Accordingly, this information has not been disclosed in this report.

Environmental Issues

The Company's operations are not regulated by any significant environmental regulation under a law of the Commonwealth or of a State or Territory.

Dividends Paid or Recommended

The Company is a Company limited by guarantee and does not have any share capital. The Company has not issued debentures. The directors of the Company are precluded by the Company's constitution from recommending the payment of any dividend.

Note 1: Statement of Significant Accounting Policies

The financial report is a general purpose financial report that has been prepared in accordance with Accounting Standards, Australian Accounting Interpretations, other authoritative pronouncements of the Australian Accounting Standards Board and the Corporations Act 2001.

The financial report covers Ausglass (The Australian Association of Glass Artists) Ltd as an individual entity. Ausglass (The Australian Association of Glass Artists) Ltd is a company limited by guarantee, incorporated and domiciled in Australia.

The financial report has been prepared on an accrual basis and is based on historical costs and does not take into account changing money values or, except where stated, current valuations of non-current assets. Cost is based on the fair value of the consideration given in exchange for assets.

The following is a summary of the material accounting policies adopted by the entity in the preparation of the financial report. The accounting policies have been consistently applied, unless otherwise stated.

(a) Company

The Company was incorporated to takeover and to continue the activities of The Australian Association of Glass Artists Inc.

(b) Income Tax

The Company is an exempt association for income tax purposes pursuant to Section 50-45 of the Income Tax Assessment Act 1997. On 14th September 2007 the Australian Taxation Office (ATO) issued a certificate endorsing Ausglass for Tax Charity Concessions. This endorsement does not alter the status that Ausglass has enjoyed since its inception. On 12th October 2007 the Australian Federal Government endorsed Ausglass as a Deductible Gift Recipient (DGR) and entered Ausglass on the Register of Cultural Organisations. A certificate formalising Ausglass' DGR status was issued by the ATO on 9th November 2007.

(c) Cash

For the purposes of the statement of cash flows, cash includes cash on hand and in at call deposits with banks or financial institutions, investments in money market instruments maturing within twelve months and net of bank overdrafts.

(d) Revenue

Revenue from the rendering of a service is recognised upon the delivery of the service to the members. Interest revenue is recognised on a proportional basis taking into account the interest rates applicable to the financial assets. All revenue is stated net of the amount of the goods and services tax (GST). Membership fees relating to future financial years are now shown as income received in advance and included in the balance sheet.

(e) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Tax Office. In these circumstances the GST is recognised as part of the cost of the asset or as part of an item of the expense. Receivables and payables in the balance sheet are shown inclusive of GST.
