# National Ausglass Exhibition, Perth Western Australia, 7<sup>th</sup> October to 28<sup>th</sup> October 2017

This Ausglass Exhibition is open to all Glass artists wishing to participate in a National exhibition. It offers an opportunity to bring together an intriguing and eclectic collection of contemporary glass. Equally it is an opportunity for the community to experience and delight in the works of some of Australia's most renowned and emerging glass artists who explore the versatility of glass as a creative medium.

#### Flair 2017 aims to:

- Promote glass in an inclusive way and to encourage experimentation within the art medium.
- Present an exciting exhibition that offers an insight into contemporary glass practice;
- Provide the City of Perth with a showcase of Ausglass members and other glass practitioners, within a national context

#### Conditions for exhibition

In keeping with the democratic spirit of Ausglass, no selection process will be applied to the Exhibition, but it is expected that artists will send their best recent work for display.

### The entrant

- Must sign the Registration Form and submit \$50.00 (Incl. GST) for Ausglass members per artwork and \$160.00(incl. GST) for Non Ausglass members per artwork, which will contribute nominally to the overall costs.
- Must sign the consignment agreement and Image release Form(Forms will be emailed to entrant after registration is received)
- Must provide at the time of entry an image on cd/dvd with minimum 300dpi. This will be used in the printed colour catalogue and publicity for the show.
- The artist guarantees that the work does not infringe the rights of any third party, including but without limitation, that the work does not infringe copyright, is not obscene, is not defamatory and is not misleading and deceptive.

#### The work

- Must have been completed since June 2016
- Must be original work made by the entrant/s
- Must be made of glass, or contain 60% glass components

- At all times the work remains the property of the artist/entrant until sold
- Copyright in the work remains at all times with the artist

#### **Entries**

One artwork per entry: (max 2 entries per person)

- Artwork may be a grouping of objects (contact curator to discuss install requirements PRIOR to deadline date)
- Jewellery, to fit onto a base of 30x30cm.
- Wall hung work weight considerations 20kg max for each component of the work
- Each Registration will receive one(1) printed catalogue and more can be ordered at the time of entry at a discounted fee

#### **Display**

- Display requirements must be fully resolved by the artist
- Track hanging is available, weight restrictions 20kg
- Suspension from ceiling is limited –(contact curator to discuss install requirements PRIOR to deadline date)
- Jewellery will be in locked cabinets unless discussed with curator one (1) month prior to exhibition setup.
- Display instructions with appropriate attachments for the work where necessary must be provided

## Flair 2017



 All electrical devices must be provided with clear and proper operation instructions and condition tagged by a qualified electrician.

Work must be reasonable with Work safe, Health and Safety requirements with respect to install and display. Works deemed unsafe by the curators, to the public will not be shown. The Ausglass Exhibitions "Flair" Curator and Gallery Central Curator will decide the final placement of all works.

#### Sale of work

- Work must be for sale.
- Commission will be 40% of the Sale Price 25% to Gallery Central and 15% to Ausglass. If the artist is GST registered the Sale Price will include GST.
- Gallery Central will be acting as the Artists Agent in any sale made.
- Payments from sales will be made to Artists by Gallery Central within two months from the close of the exhibition.
- Gallery Central will only be able to sell work for Artists who provide either an ABN or a 'Statement by a Supplier' form obtainable from the Australian Taxation Office website www.ato.gov.au

#### **Freight**

- Work to be delivered to Gallery Central, 12
   Aberdeen Street, Perth WA 6000 Australia and
   will be accepted only on 2nd, 3rd, 4th of October
   between 1-4pm. Due to limited storage please
   arrange with your shipping company to allow this
   to happen. Work arriving after the 4th October will
   not be accepted
- Transportation to and from the exhibition (and insurance for unsold work) is the organizational and financial responsibility of the artist. Failure to do so may mean the loss of the work as exhibition organisers are under no obligation to step in if the artist fails to make proper transport arrangements. This must be done in advance i.e. courier voucher, or freight company details and Account No., and a return address label. Otherwise Ausglass may return your work by Cash-on-Delivery through Australia Post if applicable
- Unsold works must be collected by which ever arrangements the artists has made on Monday 31<sup>st</sup> October 2017 between 9.00 and 1.00pm only from Gallery Central, North Metro TAFE,12 Aberdeen Street, Perth WA 6000 Australia
- There may be an opportunity to bulk ship each State's work. This is under investigation and a notice will be sent when and if this can be arranged. If you have any information on bulk transport opportunities, contact: exhibitions@ausglass.org.au.

#### Insurance

- Ausglass carries no insurance for artist's work.
- Artists are responsible for their own insurance during transportation to, and from the exhibition space and while it is on display. All care will be taken and condition reports will be made on delivery at the Gallery as well as on pack up ready for shipment.
- Ausglass excludes liability for loss, theft or damage to the artwork in the organisers' care and control

#### Closing date

Applications are due Friday 11th August 2017
No late entries due to catalogue publication
